### TC QUERUBIN (2024)

### SitRep No. 3 for TC QUERUBIN (2024)

December 20, 2024, 8:00 AM

On 17 December 2024, at 2:00 PM, the LPA east of Mindanao developed into a Tropical Depression "QUERUBIN".

At 11:00 PM, Tropical Depression "QUERUBIN" moves north northeastward over the waters east of Mindanao.

On 18 December 2024, 4:00 AM, the center of Tropical Depression "QUERUBIN" was estimated based on all available data at 230 km East of Davao City or 205 km East of Tagum City, Davao del Norte (7.5°N, 127.7°E) with maximum sustained winds of 45 km/h near the center, gustiness of up to 55 km/h, and central pressure of 1004 hPa moving north northeastward at 10 km/h. At 5:00 AM, Tropical Cyclone Wind Signal (TCWS) No. 1 was hoisted over Davao Oriental at.

At 10:00 AM, the center of Tropical Depression QUERUBIN was estimated based on all available data at 195 km East of Hinatuan, Surigao del Sur (8.5°N, 128.1°E).

As of 11:00 AM, Tropical Cyclone Wind Signal (TCWS) No. 1 was hoisted over Surigao del Sur.

At 2:00 PM, Tropical Depression "QUERUBIN" weakened into a Low Pressure Area.

At 4:00 PM, the Low Pressure Area (Formerly "QUERUBIN") was estimated based on all available data at 275 km East of Surigao City, Surigao del Norte (9.5°N, 128.0°E).

As of 5:00 PM, All Tropical Cyclone Wind Signal has been lifted

- Released Flood and Rain-induced Landslide Advisory for TC "QUERUBIN" and Shear Line valid from 17 to 22 December 2024.
- Provided the List of Barangays Susceptible to Landslides and Floodings based on the DOST-PAGASA Rainfall Data GSM and WRF 72hr.
- Posting of Geohazard Threat Advisories to MGB Social Media Accounts.
- 24/7 manning of the OpCen and processing of acquired rainfall data (observed and accumulated forecast) from DOST-PAGASA for the list of barangays to be affected by the various weather systems.

### Department of the Interior and Local Government (DILG)

Issued and disseminated the DILG Advisory on Low Pressure Area East of Mindanao, dated
 December 2024, to all concerned LGUs to continuously coordinate with their respective
 RDRRMCs and to enjoin all LGUs, especially those in areas that have recently experienced
 extended or prolonged rain events and/or landslides/floods within their respective areas of
 responsibility, and to ensure the implementation of the recommended mitigation and
 preparedness measures.

### **Department of Health (DOH)**

- Drafted a memorandum for the Kanlaon Lahar advisory due to heavy rainfall focusing on the health risks and actions to be taken for dissemination to CHDs VI, VII and NIR.
- Activated Code White Alert in DOH Central Office.
- Disseminated Weather Alert Memorandum to the CHDs.
- Attended a Pre-Disaster Risk Assessment (PDRA) Meeting.
- Coordinated with DOST-PAG-ASA on the monitored LPA.

### **Department of Agriculture (DA)**

- Issued DA Bulletin advising farmers and fisherfolks to perform the following preparedness measures:
  - 1. Regularly monitor the latest local weather information and updates;
  - 2. Harvest mature crops;
  - 3. Secure seed reserves, planting materials and other farm inputs in safe and proper storage areas;
  - 4. Relocate farm machineries, equipment and other farm tools to higher ground;
  - 5. Secure sufficient feeds and water for the possible relocation of animals;
