### **SitRep No. 12 for the Year-End Celebration and Monitoring (2024)**

**January 03, 2025 08:00 am**

The Holiday Season, encompassing both Christmas and New Year celebrations, is a period of heightened activity across the Philippines. Traditionally, many families travel to their provinces to reunite with loved ones, underscoring the cultural significance of this festive period. Christmas is observed through practices such as Simbang Gabi, Noche Buena, and gift-giving, reflecting the deeply rooted spiritual and familial values of Filipino society.

New Year's Eve celebrations are marked by widespread use of fireworks and other noise-making activities, which are integral to Filipino customs symbolizing the drive to ward off misfortune and welcome prosperity. However, these practices also pose safety risks, with incidents of fireworks-related injuries expected during this time.

Per PAGASA Special Weather Outlook for Christmas 2024, issued on 23 December 2024, the weather systems that are expected to affect most parts of the country during the Christmas Holidays are the Northeast Monsoon or Amihan, the Shear Line, and the Easterlies.

On 24 December 2024, cloudy skies with scattered rains and thunderstorms will be experienced over Metro Manila, CALABARZON, Bicol Region, MIMAROPA, Eastern Visayas, Aurora, Aklan, and Capiz due to Shear Line. The Northeast Monsoon will bring cloudy skies with light rains over Central Luzon, Cagayan Valley, and Cordillera Administrative Region (CAR) while partly cloudy skies with isolated light rains will prevail over Ilocos Region. Mindanao and the rest of Visayas will have partly cloudy to cloudy skies with isolated rainshowers or thunderstorms.

On 25 December, the Shear line will continue to bring cloudy skies and scattered rains and thunderstorms over Metro Manila, Central Luzon, CALABARZON, Bicol Region, Northern Samar, Eastern Samar, Samar, Occidental Mindoro, Marinduque, and Romblon. Cagayan Valley and Cordillera Administrative Region (CAR) will be mostly cloudy with scattered light rains while partly cloudy to cloudy skies with isolated light rains will prevail over Ilocos Region. Caraga and Davao Region will have mostly cloudy skies with scattered rains and thunderstorms due to Easterlies. The rest of the archipelago will experience partly cloudy to cloudy skies with localized rainshowers or thunderstorms.

Strong to Gale-force winds associated with the Northeast Monsoon will prevail over Northern Luzon and the eastern section of Central and Southern Luzon which may result to rough to very rough sea conditions. Moderate to strong northeasterlies to easterlies may affect the western section of Luzon and the eastern section of the country while light to moderate winds are expected over the rest of the archipelago.

Emergency hotlines and the command center will operate 24/7 to address any incidents promptly. Simulation exercises and drills will also be conducted to prepare responders for various emergency scenarios.
  - Traffic and Crowd Management: To manage the anticipated increase in traffic and crowd density, the city will coordinate with traffic enforcers to address congestion in event areas and major thoroughfares. Clear entry and exit points will be designated in crowded venues to ensure smooth movement and reduce the risk of stampedes or accidents.
