OVERVIEW	<p>On 28 December 2024, at about 7:30 AM, a vehicular accident transpired along Diversion Road near Stone Gate Subdivision, Barangay Domoit, Lucena City, Quezon.</p> <p>According to the investigation, the driver of the Toyota Commuter Hi Ace Van fell asleep and lost control of the vehicle, causing it to swerve and strike the concrete center island as it was traveling along the diversion road from Manila to Bicol. The driver and the passengers sustained physical injury and were brought to Quezon Medical Center for medical treatment.</p>
