OVERVIEW	<p>On 24 December 2024, at about 3:30AM, an information received by Lucena Police Station about a vehicular self-accident involving a Nissan Urvan Escaped Van, that transpired at Diversion Road near Stone Gate Subdivision, Brgy. Domoit, Lucena City.</p> <p>Upon investigation the vehicle was traversing along the diversion road from Manila heading to Bicol, when it accidentally hit and bumped a concrete center island. As a result, the driver of the vehicle was immediately brought to Quezon Medical Center (QMC) but declared dead on arrival, while the passenger sustained physical injuries.</p>
