OVERVIEW	<p>On 27 January 2025, at around 1:00 PM, students of Benguet National High School in Wangal, La Trinidad, Benguet practiced a six-minute dance routine at the school grounds in preparation for the upcoming CARAA event. According to their teacher, the weather was hot and humid. After practice, the students took a 30-minute break before returning to their classrooms for their usual activities. Shortly after, some students reported feeling unwell, prompting the school to request medical assistance</p>

- Conducted verification of details from the school and hospitals where the victims were admitted.
- Coordinated with MDRRMO personnel for response and reporting.
- The response team was deployed to the place of the incident.
- Transported the victims to the nearest higher health facilities.

- Ensured safety Provided ample ventilation Intravenous fluid hydration
